THE SCHOOL DISTRICT OF STURGEON BAY BOARD OF EDUCATION MEETING MINUTES OF March 26, 2014

President Kitchens called the meeting to order at 7:00 PM in the high school library. The Pledge of Allegiance was recited.

Motion: Hauser/Stephans to adopt the agenda. Motion carried unanimously

Audience to Visitors and Delegations: None

Student Council Report: Arica Smith reported that Mr. Bousley (Southern Door School District) presented to the student council regarding a Civility Project for the 2014/2015 school year. Theme for next years Homecoming is Earth, Wind, and Fire.

Recognition: The month of March has been designated as a time to recognize staff. Holly Selle was recognized.
