**Student Council Representative Report:** Student Council President Haley Herbst gave an overview of ongoing fundraising efforts as well as noting that as a reward to the student body for exceeding their \$500 fundraising goal, they will have a talent show this Friday in the auditorium.

**Recognition:** The month of December has been designated as a time to recognize staff. Mrs. Jeanne Schopf was recognized for attaining her National Board certification. Mr. Scott Steebs was recognized for transition efforts. The staff and their families were also invited to attend the meeting.

He is to be applauded for his work. Furthermore, he will also be working to re-sell the equipment that is being taken out, reducing the fiscal impact to the budget.
