President Hauser called the regular meeting to order at 7:00 PM in the high school library. The Pledge of Allegiance was recited.

a. Motion: Chisholm/Hougaard to adopt the agenda noting that we will be going into Executive Session per SS 19.85(1) (c) Considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility. Items being discussed are: Teacher increases not covered by ladder advancement, compensation request from two professional staff members, request from a former professional staff member, review of staff evaluations for nomination of 2018 Hervey Hauser award. Motion carried unanimously.

- 4. Annual Review of the Salary and Supplemental Pay Guide

The Board approved the Salary and Supplemental Pay Guide as our printed version of the adjusted faculty compensation model beginning with the 2015-2016 school year. This followed two years of study, the examination of 21 other district plans, and a number of meetings with the committee comprised of teacher representation from each school building, the Board of Education, and the administration.

Page three of the guide states: "Annually an assessment of the current framework will be conducted to determine impact, functionality, and financial sustainability. The review will be conducted by a district team under the leadership of the superintendent." The section goes on to reference the key concepts which led us to the current plan, as well as the ability of the plan to take into account priority areas, and also be sustainable—not only because of our obligation to be fiscally responsible, but because there were concerns about some of the plans studied and if they would be sustainable or not.

This year, the Compensation Committee will hold the annual review meeting the afternoon of Thursday, April 12. Since the meeting packet preparation will probably be complete prior to the review meeting occurring, I will plan to share highlights from the meeting on the night of the Board meeting, if not sooner. Board members in attendance at the review session will be welcome to share any comments or observations from their perspective as well.

No action is required of the Board, but I continue to feel that it is important to touch on the annual review process so the Board knows we are following through on our obligations—especially prior to taking action on the next agenda item pertaining to teacher contract renewal.
