President Hooker called the meeting to order at 7:02 PM in the high school library. The Pledge of Allegiance was recited.

a. STUDENT COUNCIL REPRESENTATIVE REPORT: Ms. Tess reported that 4 members packaged boxes for the Adopt a Soldier program. The council is planning a talent show with a target of raising \$700.00 through cash and canned goods & candy cane sales. The council will also adopt a family in the district to provide for that family for the holidays.

Discussion also followed about the proposed improvements to the middle school playground/parking lot improvements. Mr. Sigl talked about the discussions they have had about how to do a stepped approach to the project. Business Manager Holtz reported that an audit update every three years is required relative to an actuarial study on post-retirement benefits and what the potential liability is. The deadline is being pushed back. Referendum discussions: teacher salaries projected at 2 ¼ %, and review year 1 and extrapolate figures. We need to approve our ballot referendum question by Jan. 22, 2019. This will be addressed at the Jan 16, 2019 meeting of BOE.
 - e. Superintendent Tjernagel summarized ongoing activities for the month as well as upcoming events. The newsletter went out to the public. The base projection document from 3 years ago is being reviewed and compared to where we are at now. The board will talk more about this before we lock items in with the referendum discussion. Mr Tjernagel commended Mr. Nickel, the choir, the band and the students on a wonderful Veterans Day Program that was very respectful of all who attended.
